I will return the cart to the designated place, on the date and time noted on the rental agreement, in the same condition as when I received the cart(s). _____ (Initials)

I am aware that if the cart(s) are kept longer than the agreed upon day without the consent of Patriot Golf Carts, LLC (hereafter referred to as Patriot), there will be additional fees which include but are not limited to recovery fees, after hours fees, and additional rental fees. _____ (Initials)

Flat tires are the responsibility of the renter. Renter is responsible for the charging and cleaning of the cart(s) before returning them. I am aware that failure to comply may cause me to incur additional charges. _____ (Initials)

Gas powered golf carts will be fueled and the engine oil level checked by Patriot prior to rental. Normal rentals do NOT require the cart(s) to be refueled. Improper fuel and oil, including improper oil level, WILL damage the engine. The renter is responsible for repairs or engine replacement if engine damage occurs. _____ (Initials)

For rentals exceeding two weeks, battery powered cart batteries must be maintained. It is your responsibility to check and maintain the fluid level of the batteries while in your possession. Connections on batteries, usually nuts, must be inspected and tightened as required. If a battery(s) becomes disabled due to failure to properly maintain them, you will be responsible for the replacement of the battery(s). _____ (Initials)

Renter is responsible for damages and/or missing parts to and from cart(s) while in their possession. Renter will be liable for any court and attorney fees incurred by Patriot in pursuit of reimbursement. _____ (Initials)

Note: \$30 per cart will be charged if the cart(s) are returned un-cleaned. Renter by signing this agreement you agree to allow this charge to be placed on the credit card provided at time of booking or payment. _____ (Initials)
